#### 7) Supplemental Recruitment Initiatives.

# (a) Initiative: <u>Participation in job fairs by personnel who have substantial responsibility in the making of hiring decisions</u>

February 25, 2022 – The Employment Unit participated in the Fayetteville Marksmen College and Career Job Fair. Area highs schools were invited to attend and students could participate in different sessions (College/Vendor Expo; Business Leaders; Life After High School; & Working in Sports). Beasley Fayetteville was represented by its Sales Manager, who was also a guest speaker on the Business Leaders Panel.

### (b) Initiative: Cross-training of station personnel

A cross-training program has been established to train employees and enable them to acquire skills that could qualify them for higher level positions. The program works by enabling employees to train with each other to learn the skills necessary for the other position. During this reporting period, the following employees cross-trained in other areas: 1) On Air Personalities trained as backup to Production Manager in order to fulfill commercial copy for clients; 2) Administrative Assistant trained to be a Traffic Backup; 3) P/T Promo Assistants trained to cover Front Desk operations; 4) Sales Assistant trained in entering streaming orders as a backup to the Admin Assistant

### (c) Initiative: Intern Program

The Employment Unit has established an internship program designed to assist members of the community to acquire skills needed for broadcast employment. Interns must be juniors or seniors at an accredited institution and must be eligible to receive college class credits for the course. Internships last the length of the college semester and adhere to the requirements of the institution granting course credits with regards to the total hours worked. The Employment Unit offers internships in a variety of departments, including but not limited to: sales, promotions, programming, and production. Due to Covid-19 health and safety restrictions, the Employment Unit was unable to host interns during this reporting period

#### (d) Initiative: Management-level personnel EEO training

Employment Unit managerial staff participated in Diversity, Equity, and Inclusion (DEI) training during April, May, and June of this reporting period. The goal of the training was to promote a culture of social responsibility and belonging that advocates for hiring and developing employees of every ethnicity, race, social-economic origin, culture, age, religion, gender and sexual orientation as well as individuals with differing abilities. Examples of session topics included an overview of DEI, Best Practices in DEI, Accountability/Commitment to DEI, and Addressing Unconscious Bias. Participants included: Market Manager, Market Controller, Operations Manager, Local Sales Manager, Digital Sales Manager, Program Directors.
